

GEN 4.2 AIR NAVIGATION SERVICES CHARGES

1. General

The Maximum take-off mass (MTOW) is allowed as specified under the regulations of the State in which the aircraft is registered.

aircraft with MTOM more than 5700 and up to or equal to 9000 KG.

Note. – There is 50 percent waiver of charge for training flights.

2. Route Air Navigation Services

2.1 For International flights:

2.1.1 For aircraft with MTOW up to or equal to 9000 KG:

- a) 12 U.S Dollars for aircraft with MTOM up to or equal to 2500 KG,
- b) 24 U.S Dollars for aircraft with MTOM more than 2500 KG but less than or equal to 5700 KG,
- c) 36 U.S Dollars for aircraft with MTOM more than 5700 KG but less than or equal to 9000 KG,

2.1.2 For aircraft with MTOW more than 9000 KG:

- a) MTOM up to or equal to 150000 KG:
0.004 U.S Dollars per 1000 KG for each KM,
- b) MTOM more than 150000 KG and less than or equal to 400000 KG:
(0.0028 U.S Dollar per 1000 KG plus 0.18) for each KM,
- c) MTOM more than 400000 KG:
(0.0012 U.S Dollars per 1000 KG plus 0.82) for each KM,

Note 1: For aircraft with MTOW of more than 9000 KG Minimum charge is 100.00 U.S Dollars.

Note 2: Total Distance of each flight is calculated according to the "Great Circle" method.

Note 3: MET service charge is added to the above-mentioned charge that is 0.00006 for each 1000 KG per KM for overflying services.

2.2 For Domestic flights:

2.2.1 For aircraft with MTOW up to or equal to 9000 KG:

- a) The equivalent of 3 U.S Dollars in Iranian Rials based on the announced exchange rate for aircraft with MTOM up to or equal to 2500 KG,
- b) The equivalent of 6 U.S Dollars in Iranian Rials based on the announced exchange rate for aircraft with MTOM more than 2500 KG and less than or equal to 5700 KG,
- c) The equivalent of 9 U.S Dollars in Iranian Rials based on the announced exchange rate for

2.2.2 For aircraft with MTOW of more than 9000 KG:

- a) 26 percent of the charge mentioned in item 2.1.2, in Iranian Rials based on the announced exchange rate.
- b) Minimum charge is 50 percent of the minimum charge mentioned in item 2.1.2, in Iranian Rials based on the announced exchange rate.

2.2.3 For aircraft operating in designated areas (ATZ, CTR or TMA) with MTOW up to or equal to 9000 KG:

- a) The equivalent of 1 U.S Dollar in Iranian Rials based on the announced exchange rate for aircraft with MTOM up to or equal to 2500 KG,
- b) The equivalent of 2 U.S Dollars in Iranian Rials based on the announced exchange rate for aircraft with MTOM more than 2500 KG and less than or equal to 5700 KG,
- c) The equivalent of 3 U.S Dollars in Iranian Rials based on the announced exchange rate for aircraft with MTOM more than 5700 and up to or equal to 9000 KG.

Note: Aircraft operating in designated areas (ATZ, CTR or TMA), will be charged each 30 minutes. The minimum duration will be considered at least 30 minutes.

3. Methods of payment

The charges of all scheduled and non-Scheduled overflights should be paid by the end of each calendar month, the invoices will be sent monthly by Iran Civil Aviation Organization (Iranian Airports & Air Navigation Company (IAC)).

Note 1: All scheduled international and domestic flights operating over the airspace above the Islamic Republic of Iran's territory are required to pay the aerodrome and air navigation services charges within 30 days after the invoice issue date, regardless of their operational reasons. The payment should be made in USD or other major currencies to the account numbers indicated at the bottom of the invoices. In case of any restriction or difficulty in the payment process, please contact our financial department.

Note 2: In case of non-payment within the above-mentioned deadline, there will be a penalty for the late payment in accordance with our government regulations. The penalty is taken into the account based on the annual rate published on the official website of the Central Bank of Iran and is updated on a daily basis.
