

GEN 3.2 Aeronautical charts

1. Responsible service

1.1 Aeronautical Information Service, forms part of Iranian Airports & Air Navigation Company (IAC) under authority of Civil Aviation Organization (CAO), and administers aeronautical charts for the TEHRAN FIR.

1.3 Aeronautical charts production is based upon ICAO Standards and Recommended Practices contained in Annex 4, Aeronautical Charts as further detailed in Doc 8697, and Aeronautical Chart Manual.

Note: Accuracy requirements are not met in all cases. Any differences to Standards and Recommended Practices are published in GEN 1.7.

2. Maintenance of charts

2.1 The charts which form part of the AIP are regularly kept up to date or are replaced by AIP amendments.

2.2 Aeronautical charts are revised whenever significant changes warrant reprinting of the chart and they are distributed as per the AIRAC cycle.

2.3 Items of information found, after publication, to have been incorrect at the aeronautical information date are corrected immediately by NOTAM if they are of operational significance, attention being directed to that chart affected.

2.4 Aeronautical charts are amended by one of the following methods:

- a. Significant amendments are disseminated by NOTAM.
- b. Significant, minor or editorial changes are published in the subsequent AIRAC.

3.1 The charts listed in Para 4 may be obtained from Aeronautical Information Services. Contact methods are listed in Para 1.2

4. Aeronautical chart series available

Note: Not all charts are produced for each aerodrome. Charts are produced when required in accordance with Annex 4 - Aeronautical Charts Standards and Recommended Practices. See the appropriate AD 2-24 section for chart availability at a particular aerodrome.

4.1 The following are produced and published by the Iran AIS:

- a. Aerodrome Chart - ICAO
- b. Aircraft Parking / Docking Chart - ICAO
- c. Aerodrome Obstacle Chart - ICAO Type A
- d. Precision Approach Terrain Chart - ICAO
- e. En - route Chart - ICAO
- f. Standard Departure Chart - Instrument (SID) - ICAO
- g. Standard Arrival Chart - Instrument (STAR) - ICAO
- h. ATC Surveillance Minimum Altitude Chart - ICAO
- i. Instrument Approach Chart - ICAO
- j. VFR Chart
- k. World Aeronautical Chart (WAC)

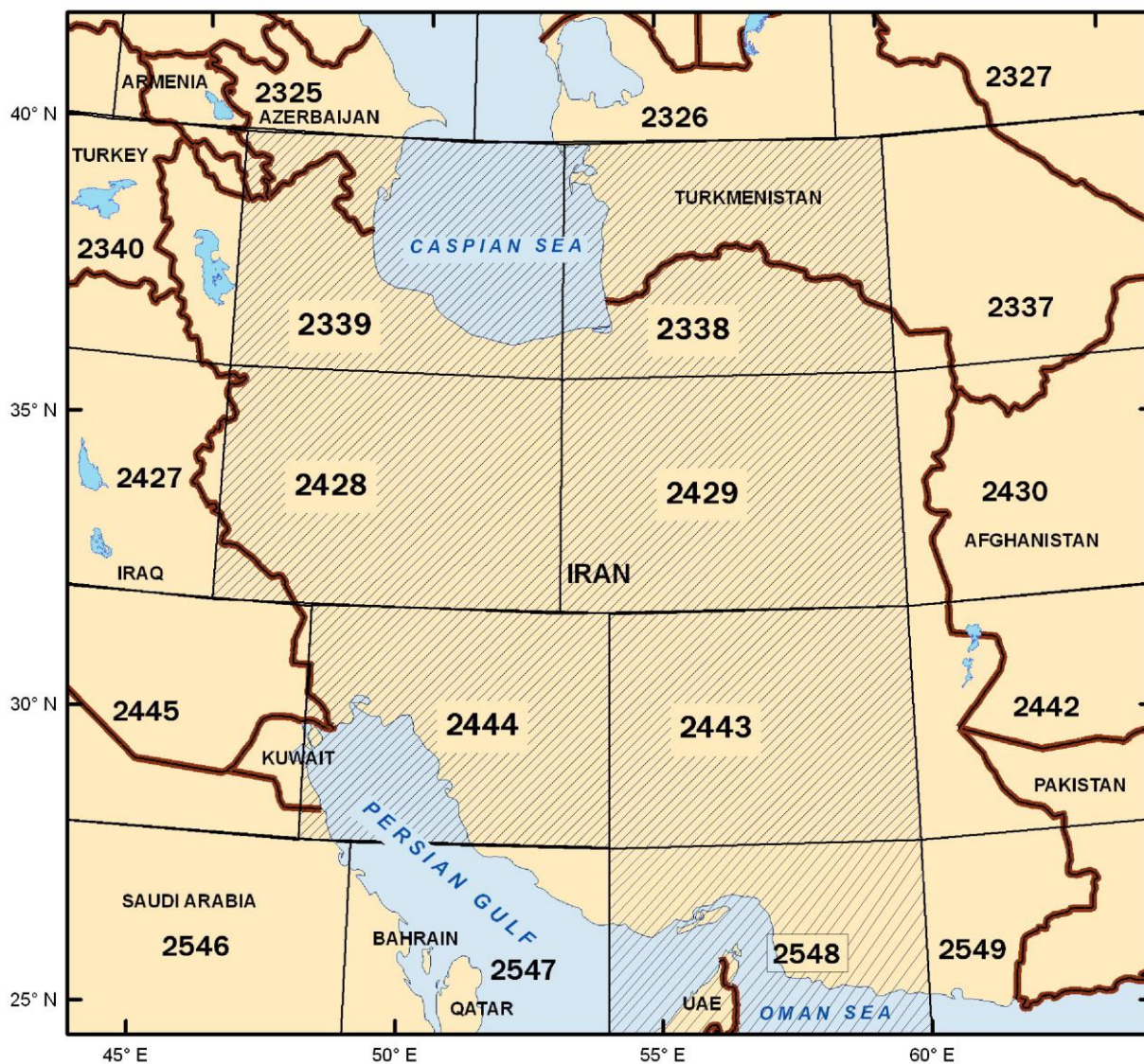

7.1 Only obstacles exceeding 328 FT (100 M) AGL are depicted. The coordinates used are not necessarily derived from a WGS 84 surveys made to aeronautical data quality standards.

7.2 The obstacles may not necessarily be complete. Caution should be exercised at all times.
